That the Higher Educational Institution categorized as Category-I University by University Grants Commission as per the University Grants Commission (Categorization of Universities (only) for Grant of Graded Autonomy) Regulations, 2018 and its amendment(s), is entitled to offer Open and Distance Learning programmes without prior

2. That the deponents have fully understood the clauses, terms and conditions as stipulated under University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments and shall at all times be in compliance with the same, as well as all other relevant regulations and instruction/direction made or issued by the UGC and other statutory/regulatory bodies concerned from time to time.

That the Higher Educational Institution shall not offer any of the prohibited programmes i.e., programmes not permitted under clause (z) of Regulation 2 of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 (including any amendments thereto). In the event, the applicable statutory or regulatory authority or regulatory council permits such programme(s), the HEI shall submit the approval or recommendation of the said authority or council, for consideration of the Commission.
5. That the Higher Educational Institution shall provide all the relevant information as required by UGC from time to time and display the same, as stipulated under Regulation 9 of the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 (including any amendments thereto).
6. That for the programmes falling under the ambit of a statutory or regulatory authority or regulatory council, the Higher Educational Institution has the approval or recommendations of the respective statutory or regulatory authority or regulatory council for offering the programmes in ODL mode, if applicable; and has also submitted the same to UGC along with the application.
7. That the Higher Educational Institution offering Undergraduate, Postgraduate and Postgraduate diploma programmes under the discipline of Management, Computer Applications and Travel and Tourism is adhering to all the norms and standards stipulated by AICTE for offering these programmes in ODL/Online mode.

13. That the Higher Educational Institution shall upload admission details on the portal (<https://deb.ugc.ac.in>) within the stipulated time, as notified by the Commission from time to time.

That the Higher Educational Institution shall state the following at appropriate places Entitled to offer ODL programmes in terms of the University Grants Commission (Categorization of Universities (only) for Grant of Graded Autonomy) Regulations, 2018 (as amended from time to time)' instead of 'UGC recognized'.


