Proctored Examination for End Semester / Term-End Examinations

1. Introduction

The Centre for Distance and Online Education (CDOE), Chhatrapati Shahu Ji Maharaj University, Kanpur, is committed to ensuring fairness, transparency, and credibility in the assessment of learners enrolled under Open and Distance Learning (ODL) programmes. In compliance with UGC (ODL and Online Programmes) Regulations, all end semester/termend examinations shall be conducted in a proctored environment.

2. Mode of Examination

- 1. **Offline (Pen-and-Paper) Proctored Examination:** Conducted at designated University-approved examination centres under the supervision of invigilators.
- 2. Online Computer-Based Proctored Examination (if applicable): Conducted through a secure online platform with AI-enabled monitoring and human proctors.

3. Proctoring System

- Physical Proctoring: Invigilators and centre superintendents deployed at examination halls.
- Online Proctoring: Combination of AI tools and human proctors to monitor learners through webcam, microphone, and screen sharing.

4. Authentication of Learners

- Verification of University-issued ID Card and Government ID Proof (e.g., Aadhaar, PAN, Passport, etc.).
- Biometric/Aadhaar-based authentication at designated centres.

5. ICT Facilities at Examination Centres

- Secure Online Examination Management System (OEMS).
- CCTV surveillance with recording facility at each centre.
- Encrypted digital question paper delivery system.
- High-speed internet connectivity (minimum 4 Mbps download, 1 Mbps upload).
- Secure login credentials for learners and invigilators.

6. Transparency & Security Measures

- Digital delivery of question papers with encryption.
- Randomized seating plan (for offline exams).
- Continuous real-time monitoring from the University Control Room.
- Strict adherence to proctor-to-student ratio as per UGC norms.
