The University is a State University of Uttar Pradesh and it is approved under section 2 (f) and 12 (B) of UGC Act since its inception. Since its beginning in 1966 the University has been universal in nature and has affiliated a large number of colleges in the districts of its jurisdiction namely Kanpur, Etawah, Aurraiya, Kannauj, Farrukhabad, Kanpur Dehat and Unnao.

Located in the biggest industrial metropolis of Uttar Pradesh, C.S.J.M. University stands out in higher education. Its sprawling campus of 265 acres is booming with academic activities. The residential campus offers both Postgraduate and Undergraduate programmes in vocational and professional education which are highly job oriented and will meet the requirements of new millennium. The departments and Institutes on campus include Business Management, Life Sciences, Bio-Sciences and Biotechnology, Health Sciences, Engineering and Technology, Pharmacy, Journalism & Mass Communication, Library & Information Sciences, Humanities and Social Sciences, Education, Physical Education, Social Work, Fine Arts and Music.

The C.S.J.M. University, Kanpur has a state-of-the-art Computer Centre and Central Library. The Computer Centre is well equipped with computing resources and caters to the academic needs of the university. The faculty and students in the University campus have free access to the computer centre and use internet facility available therein. Relentless determination, planning and investment to unite traditional library facilities with evolving electronic resources have resulted in the excellent and widely praised Ganesh Shanker Vidyarthi Central Library and E-learning environment at Chhatrapati Shahu Ji Maharaj University, Kanpur. The library is well stocked with a variety of books on management, engineering and technology, humanities and social sciences, economics, commerce, basic sciences, Hindi, and English. The library has an inventory of more than 1,63,000 print books and 35000 e books access licences to as many as 68563 electronic journals. A wide range of periodicals, journals and magazines are subscribed in the library. To cater the research community, 10130 electronic theses are made accessible through Institutional Repository available at Shodh ganga. e-platform can also be accessed through CSJMU e-Library app. Library has also access to the quality refereed journals provided by thirty renowned publishers accessible via One Nation One Subscription platform under the Govt of India initiative.

The University has become an educational centre where students of various religious and cultural backgrounds study and work together in a congenial atmosphere. The University is geared to provide maximum scholastic benefit to each individual student. In order to create a competitive environment in the area of higher education, the University is committed towards focusing on quality enhancement with clarity and precision soon.

About the Ph.D. Programme

CSJM University is offering admission to Ph.D. programme 2025-26 in various disciplines as per UGC Minimum Standards and Procedure for Award of Ph.D. Degrees Regulations 2022, its subsequent amendments and CSJMU Ph.D. Ordinance. Ph.D. programme shall be for a minimum duration of three years, including course work and a maximum of six years. This would be called as the Residency period of the Research Scholar.

No candidate would be exempted from the continuous residency period. Vice-chancellor, on the recommendation of the Supervisor may grant permission to candidate to reside outside for purpose of collection of research material for his/her thesis or doing experimental research work for a total period of not more than one year provided further that such exemption shall not be granted in the first six months after course work.

In case, a candidate fails to submit his/her thesis within Six years, from date of his/her registration, as mentioned in ordinance, he/she shall cease to be a bonafide student of the University and shall not be entitled to the rights and facilities extended to a regular student and his/her registration shall stand cancelled automatically.

However, in exceptional circumstances the extension of maximum one year may be granted by the Academic Council only if i) RDC/RAC of the candidate is satisfactory, ii) Genuine Medical grounds.

The women candidates and Persons with Disability (more than 40% disability) may be allowed a relaxation of two years in maximum duration on his/her request and permission granted by Vice-Chancellor before the expiry of Six Years. In addition, the women candidates may be provided Maternity Leave/Child Care Leave once in the entire duration of Ph.D. for up to 240 days.



Eligibility Criterion

Subject to the condition stipulated in UGC Regulations-2022 and its subsequent amendments, the following persons are eligible to seek admission to the Ph.D. Program:

- 1. The candidates should have Master's degree or a professional degree in the subjects, declared equivalent to the Master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate (or its equivalent grade 'B' in the UGC 10- point scale or an equivalent grade in a point scale wherever grading system is followed) or an equivalent degree from a foreign educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose or assessing, accrediting or assuring quality and standards of educational institutions.
- 2. A relaxation of 5% of marks, from 55% to 50%, or an equivalent relaxation of grade, may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled and Economically Weaker Section (EWS) candidates.
- 3. The eligibility marks of 55% (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the category mentioned above are permissible based only on the qualifying marks without including the grace mark procedures.

4. The candidate

- a. Provided further that an M.A. or M.Sc. in Mathematics may be permitted to work for Ph.D. degree in Statistics in the Faculty of Science.
- b.In the faculty of Medical Biochemistry, a candidate holding post-graduate degree in the concerned or allied subjects or equivalent degree of another University recognized by this University/having a post graduate degree with at least 60% (55% for SC/ST/ Differently-abled candidates) marks shall be eligible for admission to the Ph.D. programme.
- 5. Students appearing for final year or final semester of their postgraduate degree examination will also be eligible to appear for the admission process subject to the fulfilment of minimum eligibility criteria in the result thereof.

Note: Candidates are advised to check their eligibility to appear for the CSJMU Ph.D. admission program. The eligibility will be verified at the time of counselling by producing original testimonials /documents. For any eventuality at the time of admission candidates will solely be responsible.

Admission Process

Candidates must have qualified at least one of the following national-level examinations for eligibility: (CSIR-UGC NET / GATE/ICMR/ICAR)

- CSIR-UGC NET (JRF/Assistant Professor/Ph.D. admission only)
- GATE (Graduate Aptitude Test in Engineering)
- ICMR (Indian Council of Medical Research JRF/Ph.D. programs)
- ICAR (Indian Council of Agricultural Research AICE-JRF/SRF or equivalent)

Candidates with valid certification/scores in any of the above are eligible to apply for admission to the Ph.D. program, subject to fulfilling other academic and institutional requirements.

- 1. Admission through Entrance Test:
 - a. An entrance examination (CSJMU Entrance Test -2025) will be conducted by the University for the admission of Ph.D. applicants in the fields of MEDICAL LABORATORY TECHNOLOGY and PHARMACY.
 - b. CSJMU Entrance Test -2025 will be conducted in OFFLINE mode at CSJMU campus Kanpur only.
 - c. A candidate seeking admission to the Ph.D. programme shall be required to secure at least 50% marks in CSJMU Entrance Test -2025.
 - d. There will be 5% relaxation in marks for OBC/SC/ST candidates i.e. 45% will be qualifying marks .
- 2. Assessment Criteria for qualified candidate through common test (CSIR-UGC NET / GATE/ICMR/ICAR) OR through CSJMU Entrance Test -2025 will be called for the interview and the final selection will be based on the Interview Performance (100 % Weightage)
- 3. The admission shall be based on the criteria notified by the University, keeping in view the guidelines/norms in this regard issued by the UGC and other statutory bodies concerned and taking into account the reservation policy of the State Government of Uttar Pradesh from time to time into different Vertical and Horizontal-categories viz. unreserved, reserved for OBC/SC/ST/Differently-Abled/General-EWS and so classified for each Department/Subject. The social category mentioned in the application form cannot be changed/modified at any stage.
- **4.** Guidelines for conducting written examination (applicable subject) for persons with disabilities will be followed as defined in Rights of persons with Disabilities Act, 2016 (RPwD Act, 2016) which came into force from 19-04-2017.
- **5.** Scheduled Castes/ Scheduled Tribes and Other Backward Classes candidates of other states will be treated as general.
- **6.** All original certificates have to be produced at the time of interview along with ID proof, two sets of Photocopies and two recent coloured photographs
- **7.** Candidates are advised to consult frequently consult the University website for the official announcement regarding interview dates and times.
- **8.** The overall merit list would be prepared on basis of marks obtained interview. This list would be displayed on the University's website.
- **9.** All admissions are provisional. University reserves the right to cancel any admission at any stage.

- *** If two or more candidates have secured equal marks in the admission will be determined as follows:
- 10. If the merit Index of candidates are same in such cases first preference will be given to the candidate who secures higher score in qualifying examination (CSIR-UGC NET / GATE/ICMR/ICAR)
- 11. If the marks secured in qualifying examination (valid NET, JRF score and entrance test) are also same, in such cases first preference will be given to the candidate who secures higher percentage of marks in post graduation examination.
- 12. If the marks secured in post graduation examination also same, in such cases first preference will be given to the candidate who secures higher percentage of marks in graduation examination.
- 13. Full time Ph.D. candidates are not permitted to undertake any remunerated assignments or employment during their enrollment, with the exception of fellowships, scholarships, or other stipends awarded for the purpose of pursuing the program
- 14. The prescribed Annual Fee for Ph.D. Program shall be applicable for the candidates admitted in the session 2025-26.
- 15. Number of seats may vary in different Departments as per availability of Supervisor and as per the decision of the competent authority of the of CSJMU University Kanpur.
- 16. The vacancies in any subject of Ph.D. may increase/decrease at the time of finalization of result.
- 17. The University reserves the right to deny admission to Ph.D. program in any of its constituent colleges/departments/centers.
- 18. The details entered by the applicant in the form will be verified before the interview. If it is found incorrect at any stage, the candidature shall be rejected and he/she shall not be entitled to claim any relief of other concession in that regard
- 19. In any case, the application fee shall not be refunded or carried forward regardless of whether a candidate's application is rejected.
- 20. The candidate can fill either the Ph.D. seat for the campus or the college; however, a Candidate can fill both forms (college and campus) separately with the prescribed fee. The candidates need to select the appropriate option in the online application form.
- 21. Applicants are advised to check the website regularly for notices and announcements regarding Ph.D. process.

Exemptions from the Entrance Test

The following categories of candidates shall be exempted from the Entrance Test for admission to Ph.D. programme:

- 1. International students which shall be subject to the general rules framed by the Government of India from time to time and as applicable to the University about the admission, fees etc.
- 2. Serving Army, Navy, and Air-force Officers of at least Colonel or equivalent rank with not less than 15 years of service applying for Ph.D. degree in concerned/allied/relevant disciplines.
- 3. To promote the industry-academia relations, candidate sponsored by industries will be admitted to the Ph.D. program through an interview process conducted within the university campus. However, successful completion of the Ph.D. course work will be mandatory for the research scholars.
- 4. Sponsoring organization will be assigned as research centre and will bear the research cost of the sponsored candidate.
- 5. Assistant Professors, Associate Professor having appointment on regular posts in the teaching departments of the University or a government college / government aided college affiliated/associated to the University who have completed their probation successfully would be required to appear in the interview.
- 6. A final merit list will be produced based on the interview results. This list would be available on the university's website.
- 7. The candidates shall appear for interview and presentation before a selection committee constituted for respective fields on the date(s) announced through the website of the University.
- 8. The qualified applicants, in order of merit in each subject would be called for Course Work as per the available number of vacant Ph.D. seats.

Note:

- a. Any dispute arising out of this notification is not subject to jurisdiction. The University reserves the right to make changes to the terms and conditions without prior notice. All decisions made by the University shall be final. Any dispute or claim shall be settled in accordance with the University terms and conditions. The University shall not be held liable or responsible for any claims or losses.
- b. Ph.D. admission committee /competent authority will make the final decision on any dispute.

General Guidelines for Filling up the Application Form

The Ph.D. Application form has to be filled online for admission to the Ph.D. Program.

- 1. The Online Application form will be filled by all applicants seeking admission for the Ph.D. program in any subject.
- **2.** Before applying online, candidates are required to keep ready the following documents for uploading
 - a. Soft copy of colour photograph
 - **b.** Soft copy of signature
 - c. Category Certificate (if applicable)
 - d. 10th & 12th level Mark sheets
 - e. UG Mark sheet and Degree Certificate
 - f. PG Mark sheet and Degree Certificate
 - **g.** Mark sheet of previous semester(s) for candidates appearing in the qualifying degree exam
 - h. (CSIR-UGC NET / GATE/ICMR/ICAR) score card.
- 3. Applicants are advised to go through the eligibility criterion before filling the application form for Ph.D. admission. However, mere fulfilment of eligibility criteria does not give guarantee for admission to the Ph.D. Programme.
- 4. University shall not be liable for the correctness and authenticity of the information/ documents provided in the online application.
- 5. The University has the right to cancel, at any stage, the admission for the candidate who is found admitted to a course to which he/she is not entitled, being ineligible in accordance with the statues and regulations in force or it is found that the documents submitted by the candidate are not genuine.
- 6. Merely submission of an application form, does not constitute a claim for a seat or admission to the Ph.D. program. All admissions are provisional. University reserves the right to cancel any admission at any stage.
- 7. Ph.D. admission related information are available on the link "Online application for admission to Ph.D. Degree Programme 2025" at the University website www.csjmu.ac.in.
- 8. Prospective candidates are advised to keep visiting the university website (www.csjmu.ac.in OR https://csjmu.ac.in/csjmu-research/) regularly for announcements, notices and updates, because no separate information shall be sent to any prospective candidates. In case of any matter relating to the Ph.D. admissions, the decision of the Vice Chancellor/Ph.D. admission Committee, CSJM University shall be final and binding.
