# **NOTIFICATION**

# Admission against Sports Quota in Under/ Post Graduate Programmes

In pursuance with provision of the University Sports Policy 2023, the constituted Body i.e Sports Council on the recommendation of Chairman of the Committee and Academic Council of the University approved the Sports Quota admission in various UG/PG programmes offered at University Schools of Studies along with their Constituent and Affiliated Colleges/Institutes w.e.f. the academic year 2024-25.

The candidates will follow the below mentioned guidelines for admission on the basis of Sports Quota. All the applicants applying for admission in this category shall require to meet the common minimum eligibility conditions as follows:

 APPLICABILITY: The Sports Quota Admission will be applicable to all UG/PG Programmes offered at University Schools of Studies along with their Constituent and Affiliated Colleges/Institutes with effect from Academic Session 2024-25, provided the Regulatory Bodies like AICTE, BCI, NCTE, COA etc., does not have any objection in the matter, wherever applicable.

# 2. QUANTUM:-

- a) For Supernumerary Seat(s): Not exceeding 02 Seats of the total of intake of programme shall be earmarked as Supernumerary Seat(s).
- b) For Discipline Specific Seat(s): Not exceeding 10 Seats of the total of intake in each Sports/Games shall be earmarked as Discipline Specific Seat(s).
- 3. <u>EDUCATIONAL QUALIFICATION AND ELIGIBILITY CRITERIA</u>: Candidates desirous for consideration in Sports Quota are required to fulfil the minimum eligibility conditions prescribed for particular UG/PG programme(s) in the respective Admission Brochure 2024-25.
- 4. TERMED CATEGORY FOR SPORTS QUOTA & THEIR WEIGHTAGE THERE OFF FOR UNDER/POST GRADUATE PROGRAMMES:-
  - (i) Category A\*\* & A\*: Admission without Sports Trial.
  - (ii) Category A, B, & C: Admission on the basis of achievements in National/State level events and performance during the Sports Trial.

Note: Admission on the basis of Sports Quota for termed Categories will be based solely on the scrutiny of the Uploaded /Submitted Merit/Participation Sports Certificate and order of the preferences of course /streams opted by the candidates in the Application Form. The allocation will be done on the basis of fulfilling the minimum eligibility criteria for a particular programme and in the order of choice-cum-merit of the preferences of Programme and subject to availability of the seat in the University School of Studies along with their Constituent and /Affiliated Colleges/Institutions in the respective programme.

- 6. ADMISSIONS WITHOUT SPORTS TRIAL FOR UG/PG PROGRAMMES (CATEGORY A\*\* & A\*)-
- 6.1 Admission on the basis of without Sports Trial: These are termed Category A\*\* & A\* Candidates. The criteria for admission of Category A\*\* & A\* Candidates will be based solely on the scrutiny of the Uploaded/Submitted Merit/Participation Sports Certificate submitted by the candidate along with the Application Form. The Candidate must have fill the Application form for admission to a Particular Programme. The allocation will be done on the basis of fulfilling the common minimum eligibility, program-specific eligibility prescribed in the Admission Brochure and subject to availability of the seat pertaining to Sports Quota at University Schools of Studies along with their Constituent and Affiliated Colleges/Institutes.
  - a) Candidate who have represented India in the below-mentioned competitions, will be given admission without Sports Trial provided on the basis of Performance in Sports; wherein Sports Championship/Tournaments/Completions are Organized under the aegis of :- "International Sports Competitions approved, recognized and funded by the Ministry of Youth Affairs and Sports (MYAS)/ SAI/ IOA/ FISU/ National Federation of concerned Games approved/ Association of Indian Universities/ School Games Federation of India"

# 7. ADMISSIONS WITH SPORTS TRIAL FOR UG/PG PROGRAMMES (CATEGORY A, B & C)-

7.1 Admission on the basis of Sports Trial: These are termed Category A, B & C Candidates. The criteria for admission of Category A, B, and C candidates will be based on comprising 40% of weightage in merit of the highest marks obtained by the candidate in the evaluation of uploaded/Submitted Merit/Participation Sports Certificate and the rest 60% of the highest score obtained by the candidate in the said Sports Trials.

For candidates in Categories A, B, and C (admission on the basis of sports trial for UG/PG Programmes) weightage will be awarded on the basis of Uploaded/Submitted merit/participation Sports Certificate in application form for the Game/Sports.

Admission in Sports Quota Seats shall be based on team Games and Individual Sports, which shall be decided by the University as per availability of facilities in the campus.

- a) Evaluation of Sports Certificate (Maximum 200 marks): 40% weightage based on the achievements after scrutiny of the Sports Merit/Participation certificate (s) Uploaded/Submitted by the candidate.
- b) Sports Trial (Maximum 300 marks): 60% weightage on the basis of Performance in Sports Trial.
- 7.2 Marking/ Evaluation of Sports Certificate (Maximum 200 Marks): 40% weightage in (Category A, B & C).

Criteria for evaluating/marking Uploaded/Submitted Merit/Participation Sports Certificate(s) and displaying the marks for different levels of Games/Sports competitions is given below:-

 The Sports Certificate of Invitational/Memorial/Open/ Prize Money league/Selection Trial/Squad/Ranking competitions will only be considered if Sports Competitions are approved, recognized and funded by the Ministry of Youth Affairs and Sports (MYAS). Letter/Letterhead of Merit/Participation in Sports competitions will also not be considered.

2. The candidates can upload self-attested copies of a maximum of three Merit/Participation Sports Certificates.

- 3. The Uploaded/Submitted Merit/Participation Sports Certificate will be evaluated as per the Criteria for marking of the Uploaded/Submitted Merit/Participation Sports Certificate. However, the highest marks obtained by the candidates in the evaluation of Uploaded/Submitted Merit/Participation Sports Certificate will be considered for the preparation of the Merit.
- 4. Sports Certificate of the preceding three years only will be considered from 01st May 2022 to 30th April, 2024.
- 5. Incomplete/Cutting/Overwriting in the Uploaded/Submitted Merit/Participation Sports Certificate will not be considered for marking under any circumstances.
- 6. The level of competency of the candidate will be determined only for those who have achieved distinction during the preceding three years as stated in para 4 above in the game/Sport mentioned at sports category.
- 7. The candidate must secure a minimum of 20 Marks in the evaluation of the Uploaded/Submitted Merit/Participation Sports Certificate to be eligible for consideration in merit and for the Sports Trial/s.

# 7.3 Marking/Evaluation of Sports Trail (Maximum 300 Marks): 60% weightage in (Category A, B & C).

For different Sports & Games Considered for Admission on according to Team/Individual Games as prescribed for the University Sports Policy.

(i) Fundamental Skills: 100 Marks

(ii) Performance in Trial: 120 Marks

(iii) Performance in Physical Fitness: 80 Marks

#### Notes:

- a) The candidate shall be allowed to appear in the Sports Trial/s only in one Event/Weight Category.
- b) The teams who are conducting Sports Trial should arrange for due video-grapy of the activity of Sports Trial without fail and preserve the recordings there off.
- c) The Competent Authority of CSJM University shall constitute the Committee for conduction and evaluation of Sports Quota admission of the University.

### 7.3 Seat Allocations:

- 1. For allocation of seats for Sports Quota, preference will be given to Category A\*\* & A\* candidates.
- 2. For allocation of seats for Sports Quota to Category A, B and C, Candidates Merit of the candidates will be considered.
- 3. The Combined Sports Merit (CSM) Score of a candidate will be summation of:
  - a) 40% of the highest marks obtained by the candidate in the evaluation of Uploaded/Submitted Merit/Participation Sports Certificate, and
  - b) 60% of the highest score obtained by the candidate in the given Sports Trials.
- 4. Allocations will be done on the following criteria:
  - a) CSM ranking of the candidate.
  - b) Preferences of Program/Streams in the USS filled by the candidate.



- c) Subject to Availability of seats for the specific Game/Sport offered at University Schools of Studies along with their Constituent and Affiliated Colleges/Institutes opted for by the candidate.
- 5. In subsequent rounds (if any) for admission on the basis of Sports Quota, the Candidates who are already been admitted on a Sports Quota Seat will have option for 'Upgrade' to be considered for a higher preference of program/streams in the University Schools of Studies along with their Constituent and Affiliated Colleges/Institutes in accordance with the preferences filled by the candidate subject to availability of seats.

# **IMPORTANT INFORMATION:**

- 1. The Sports Admission Committee of the University shall verify the Uploaded/Submitted merit/participation Sports Certificate evaluated/marked from the original Merit/Participation Sports Certificate of the candidate. To conduct the sports trial, it will be the responsibility of the Secretary, Sports. The Sports Quota shall be conducted by the Sports Admission Committee constituted by the Competent Authority of the University.
- 2. The marks awarded on the Uploaded/Submitted Merit/participation Sports Certificate which are displayed on the University website are provisional and are subject to final scrutiny and verification of the Merit/Participation Sports Certificate by the Sports Committee of the University. The decision of the Sports Committee of the University shall be final.
- 3. The grievance related to the award of marks of Uploaded/Submitted Merit/Participation Sports Certificate shall be considered by the UG Sports Grievance Redressal Committee of the University. The marks of the Uploaded/Submitted Merit/Participation Sports Certificate shall be displayed on the University website for three days to register the grievances, if any. All registered grievances shall be resolved within seven days by the Sports Grievance Committee of the University.
- 4. A candidate's name appearing in the Sports Merit List does not guarantee admission in a program and the University. The admission of the candidate is subject to the availability of seats in a program in the University and shall also be subject to fulfilment of program-specific minimum eligibility criterion of the Department and as per University regulations.
- 5. The list (soft copy) of finally admitted candidates in the Sports Quota shall be sent to the Dean, Academic within seven days of the last date of admission to the University. Dean, Academic shall issue the enrolment numbers to such admitted candidates. Dean Students Welfare/ Seceretary, Sports shall notify the detail SOPs for admission to Sports Quota well in advance on the University website.
  - a) In order to be eligible in Sports Quota, a candidate should have passed the last qualifying examination and submit the Marksheet alongwith Migration in the university at the time of admission.
  - b) All candidates required to submit fitness certificate certified by Chief Medical Officer, District Hospital at the time of admission in UG & PG Programs.
  - c) The candidate must submit an Undertaking on Non-Judicial Stamp Paper of Rs. 100/- at the time of admission stating that the candidate will practice and participate for the College, and if selected, will represent the University in the Sports Competitions as determined by University. In case the student violates the above referred Undertaking, the University has the right to cancel his/her admission.

- e) A candidate, as per his/her age must be eligible to participate in Inter-University competitions for the next two years and should not be employed on a Part-time/Full-time basis anywhere.
- f) Any injury/casualty caused to the candidate during Sports Trial shall be the sole responsibility of the candidate himself/herself.
- g) The University shall maintain a proper record of the documents of the candidates admitted on the basis of Sports.
- 6. All admission on the basis of Sports Quota are provisional and are subject to forensic examination/verification of the originals of Uploaded/Submitted Merit/Participation Sports Certificates of the candidate. Candidate submitting false/fake Merit/Participation Sports Certificates for seeking admission on the basis of Sports Quota, shall be debarred from admission to the University for three years. Such admissions will be cancelled and strict legal action will also be initiated against the student.
- 7. 100% Scholarship for International Players and National Medal winners where their education for the course and hostel accommodation shall be provided free of cost. Other facilities/scholarship/cash prize/money shall be provided as per Sports Polciy-2023 of the University.

Sports Admission Committee shall prepare the Application Form which will be placed on the University website. Subsequently, Office of DSW/Seceretary, Sports will prepare the common merit amalgamating weightage/score, marks scored on the basis of Uploaded/Submitted sports certificate and sports trial as mentioned in Category A\*\*, A\*, A B, & C wherever applicable. All information will be provided to Dean, Academic/Admission for the completion of admission process.
