

# **Guidelines for Admission to B.Tech. Programs through SPOT Counselling against Vacant Seat for Session 2021-22**

Admission to B. Tech Programme (Six branches of engineering: CHE, CSE, CSE (AI), ECE, MEE, and MSME) is done through UPCET counseling for JEE (Main) qualified candidate, organized by AKTU, Lucknow.

Once the UPCET counselling procedure is over (all rounds of counseling), it allows the institute to fill their vacant seats after internal sliding at the institute level.

UIET admission cell will perform the Internal Sliding (branch shifting) considering the choices of admitted candidates (through UPCET Counselling-2021) as per their **their rank and category**. In case a candidate is offered an upgraded seat he/she cannot withdraw the same. Candidates are required to carefully opt for Internal Sliding.

Thereafter, remaining vacant seats including the seat vacated due to admission withdrawal in all the branches are converted to **“General Open Seats” without considering any kind of reservation.**

The vacant seats shall be filled strictly in the following preference order

- (i) Firstly, by the qualified candidates of JEE (Main) -2021 fulfilling the eligibility as per clause 2.1 and 3.1\* for B. Tech . Their relative merit will be decided on their rank in JEE (Main) entrance examinations-2021.
- (ii) Secondly, the qualified candidates of UPCET (UG) Entrance -2021 fulfilling the eligibility as per clause 3.1\* and having Mathematics as a compulsory subject in 10+2 examination. Their relative merit will be decided on their rank in UPCET (UG) Entrance -2021
- (iii) Finally, by the meritorious candidates, who have passed (10 + 2) examination from U.P. Board/CBSE/ICSE or its equivalent from any other recognized Board on

session 2020-21 with a minimum of five subjects in which Physics, Chemistry, and Mathematics are compulsory subjects. Their relative merit will be decided on their percentage in Physics, Chemistry, and Mathematics in the above examination-2021.

Candidates are advised to read the guidelines carefully before reporting to the Institute.

1. The academic eligibility criteria are as follows:

The JEE (Main) - 2021 candidate must have passed (10 + 2) examination from U.P. Board/CBSE/ICSE or its equivalent from any other recognized Board with a minimum of five subjects in which Physics, Chemistry, and Mathematics are compulsory. Candidates must obtain at least 45% marks (40% for SC/ST candidates) in aggregate. In addition, all other eligibility criteria as per JEE (Mains) Examination- 2021.

- (a) A Candidate who is a domicile of Uttar Pradesh, i.e. he/she has passed the 10+2 qualifying examination from an Institution located in U.P. is eligible for counseling.
- (b) In case, the candidate has passed the qualifying examination from outside U.P., and belongs to U.P. shall submit the Permanent Residence Certificate (issued after 1st April 2021) of his/her parents (Father or Mother).
- (c) Candidates who are wards of Defence Personnel settled or posted in UP on the date of Entrance Examination of JEE (Mains) 2021 or Officers /Employees of All India Services belonging to UP Cadre are also eligible. They are required to submit Certificate No. 5 to claim the benefit.
- (d) A Candidate who is a domicile of other states, and he/she has passed the 10+2 qualifying examination from an Institution located in U.P. is eligible for counseling.

- (e) A Candidate who is a domicile of other states, and he/she has passed the 10+2 qualifying examination from an Institution located outside U.P. is eligible for counseling.
2. The candidates for whom the result of the qualifying examination has not been declared till the SPOT Counselling due to any reason, whatsoever, shall not be eligible for admission under any circumstances.
  3. Formats for various certificates to be submitted are available on the CSJMU, Kanpur website ([www.csjmu.ac.in](http://www.csjmu.ac.in)). These formats are subject to change as per the orders of the Government of Uttar Pradesh. Note that the certificate for Income Certificate for EWS candidates will be entertained only if it is issued on or after 01.04.2021.
  4. If any document/declaration submitted by the candidate is found to be false at any stage, his / her candidature will be canceled and he/she may be legally responsible for action under the law. In case of any legal dispute, the jurisdiction will be limited to Kanpur Court only.
  5. Accepting admission in UIET, CSJMU Kanpur implies the acceptance by the candidate and his/her parents or guardians of all the terms and conditions laid down by the University. Any change in the rules, regulations, or other specific conditions, etc. of the University shall apply to the admitted candidates.
