## MEMORANDUM OF UNDERSTANDING

## 2. Objectives and Responsibilities

# A. It shall be an University Industry Participation that will promote the following:

The Parties acknowledge and agree that Super AI may fulfil its obligations under this MOU through its affiliates, and/or other Super AI Polaris local organizations or partners, even when not expressly stipulated in this MOU.

#### 6 TERM.

The MOU will remain effective until 14-1-2025 unless either Party terminates the MOU earlier by written notice. It is understood that such earlier termination will not entitle the other Party to any refund, damages, or other compensation. The Parties will review the operation of the MOU prior to its expiryand will jointly determine its renewal or revision.

## 9 RELATIONSHIP OF THE PARTIES.

The relationship of the Parties as described in this MOU is strictly that of independent parties. Neither this MOU as a whole nor any specific term or condition will be interpreted as creating a partnership, joint venture, agency, or franchise relationship between the parties.

## 10 LIMITATIONS OF LIABILITY AND INDEMNITY.

The Parties mutually agree that to the full extent permitted by law, neither Party will be liable to the other for any direct, consequential, indirect or special damages arising out of or related to this MOU, except with respect to violation of the other Party's confidential information or intellectual property rights

### 11 CONFIDENTIALITY

The Parties acknowledge that, in the course of their negotiations under this MOU, it may be necessary for one Party to provide documentation, technical and business information and/or intellectual property, in whatever form recorded (collectively "Confidential Information"), to the other party. All Confidential Information provided or disclosed by either Party hereunder shall remain the property of the furnishing party and shall be held in strict confidence by the receiving Party, unless the furnishing Party required by the applicable laws. Confidential Information furnished by any party hereunder (i) shall not be reproduced or copied, in whole or in part, by the receiving Party except for use as specifically authorized by this MOU;(ii) shall together with any copy thereof, be returned to the disclosing Party, or at the request of the disclosing Party, destroyed, when no longer needed for purpose of this MOU; and (iii) shall only be disclosed by the receiving Party to its employees who have a need to know such Confidential Information in connection with the performance of this MOU; and who have agreed to comply with the confidentiality obligations set forth herein.

## 12. Communication Plan and Right to Use Name / Public Announcements

University and Super AI will create a communications plan to ensure the mutual public promotion of the Parties' relationship and awareness of the Parties' initiatives and activities. The communications plan will include but will not be limited to the following items:

- (ii) internal communication between Company and Super AI
- (iii) recognition and promotion of the Parties' relationship and role with respect to the MOU/project undertaken under the MOU in the various communication materials.
- (iv) The Parties further agree to provide adequate publicity to the content of their collaboration. The Parties will collaborate in planning and publishing a joint press release, which will describe the content of this collaboration.
- (v) For all other press releases, public announcements, and negotiations with third parties, neither Party may use the name of the other Party, except with the prior written consent of the other Party, which shall not be unreasonably withheld.
- (vi) Neither Party may use the name of the other Party as a reference in negotiations with third parties, except with the prior written consent of the other Party.

#### 13 APPLICABLE LAW, JURISDICTION.

If any dispute arises out of this MOU between the Parties, then the Parties shall resolve that dispute by negotiations in good faith. If the dispute cannot be resolved within sixty (60) days of commencement of negotiations, then the same will be referred to arbitration. The arbitration tribunal shall comprise of three arbitrators, one to be appointed by each Party and the third arbitrator to be appointed by the two arbitrators so appointed. Such arbitration shall be governed by the Arbitration and Conciliation Act 1996. The arbitration proceedings shall be in the English language. The venue of arbitration shall be New Delhi, India. The arbitral award shall be final and binding upon the Parties, and each Party agrees to bear its own costs of arbitration and to equally share the fees of the arbitration tribunal, unless the arbitration tribunal decides otherwise.] The validity and interpretation of this MOU shall be governed by the laws of India and Parties shall be subject to the exclusive jurisdiction of the Courts of New Delhi to entertain any suits relating to enforcement of the award and/or any injunctive relief.

#### 14. EXPENSES

Other than as provided elsewhere in the MOU, or the exhibits each Party shall bear its own costs and expenses incurred in connection with the performance of their obligations under this MOU.

#### 15. Validity

The MOU is valid for a period of three years with effect from the date of signing the MOU and may be renewed after that period, incorporating mutually agreeable modifications if any thereafter. Each party may withdraw from the MOU by giving a written notice of three months in advance, subject to fulfill prior obligations otherwise surviving.

#### **16. ENTIRE MOU**

This MOU supersedes all prior discussions and understandings (whether oral or written, including all correspondence) between the parties with respect to the subject matter of this MOU, and this MOU constitutes the sole and entire understanding between the parties with respect to the subject matter hereof.
