National Institute of Technical Teachers' Training and Research, Kolkata (herein afterwards referred to as "NITTTR,K"), which expression shall include its legal successors and / or permitted assigns of the other part and Chhatrapati Shahu Ji Maharaj University, Kanpur (herein afterwards referred to as 'CSJMU'), which expression shall include its legal successors and / or permitted assigns of the other part hereby agree to sign a Memorandum of Understanding (MoU). Both the above being herein after collectively referred to as the "Parties".

The MOU shall cover the following as under-

1.0 BROAD OBJECTIVE

NITTTR,K will collaborate and extend support in making the undergraduate and post-graduate technical education more effective by bringing about qualitative changes in the overall teaching learning system followed in CSJMU during the next five years.

2.0 SCOPE

NITTTR,K shall provide support to CSJMU in developing quality teaching-learning process with regards to the undergraduate and post-graduate (including doctoral) programmes in engineering and allied disciplines pursued by various departments of CSJMU with the help of IQAC, CSJM University. The scope under the MOU will include details as appended below-

2.1 Improving quality of teaching at the UG & PG levels

The scope of the MOU shall cover the following items:

- i. NITTTR,K shall help CSJMU in bringing about comprehensive quality improvement in the teaching skills of the faculty of its constituent / affiliated institutions through need-based training programs that will be a combination of existing programmes and

and also newly developed training programmes. However, both the parties will try to organize training programmes during vacation time of teachers.

- ii. In order to offer focussed training programs based on the skill-sets required at the individual/ group level, it would be essential to assess the training needs of the target groups. To this effect, NITTTR,K would conduct need-assessment exercises in project mode, from time to time, during the period in which the MOU would be in force.
- iii. Areas covered under training programs would include refresher courses, content updation, educational technology, professional skill development, total quality management approach in education etc. Further, if need arises to address a new area for faculty performance enhancement, such training program/s would be developed jointly in a project mode on a case to case basis.
- iv. NITTTR,K would provide selective (to be decided jointly) access its resource materials to CSJMU in both print/ electronic medium. This would at least include the study materials related to the training programs, NITTTR,K library to CSJMU faculty members and also to any of its authorized persons as per existing provision of NITTTR,K.
- v. Further, CSJMU will have access to NITTTR,K's advanced in-campus laboratory facilities the details of which would be jointly worked out as and when required.
- vi. NITTTR,K shall assist CSJMU in making reference materials (journals, thesis etc.) available for the PG/UG work as per specific need.
- vii. NITTTR,K and CSJMU shall jointly identify areas of research in the field of Educational Technology and Educational Management from time to time.

2.2 Improving organizational effectiveness

With regards to the above scope of the MOU, following would also be included -

- i. NITTTR,K can initiate a comprehensive study (on a project mode), with active cooperation of IQAC of CSJMU, to rank the

- institutions affiliated under the university. Such a study would throw light on the overall status of the affiliated institutions and will also help the authorities to zero-in on the specific interventions needed by a specific or a group of institutions.
- ii. NITTTR,K can also undertake a SWOT analysis (on a project mode) to understand the present status of the university/ institutions in regard to manpower, technology, infrastructure, efficiency etc. Such comprehensive studies from time to time, will help the authorities in taking new initiatives as also fine-tuning the existing ones.

3.0 FINANCIAL ASPECTS

- i. The cost of organizing training programs, studies and other activities etc. would be jointly worked out based on the scopes and deliverables. The details would be worked out on a case-to-case basis [in this regard, Table 1 given in **Annexure -1** may be referred to].
- ii. Apart from the training programs (as mentioned in Annexure-1), the travelling and the hospitality expenses of the personals of CSJMU shall be borne by the CSJMU.
- iii. The mode of payment, including advance payment etc. wherever applicable shall be mutually worked out.

4.0 INDEMNITY CLAUSE

CSJMU shall indemnify NITTTR,K from the risks of any liability through the various affiliated and constituent institutions of the former.

5.0 INTELLECTUAL PROPERTY RIGHT

The IPR created out of any joint research and learning shall be the common property of the Parties (NITTTR,K and CSJMU). Parties can thereafter commercialize the IPRs on mutually agreed terms and conditions. However, IPRs existing prior to the MOU at the disposal of either of the parties shall be excluded from any joint ownership.

6.0 PERIOD OR VALIDITY OF THE MOU

The MOU shall remain valid for a period of five years initially, starting from the date of signing the MOU. The MOU can however, be extended or terminated through mutual consent.

7.0 OPERATIONALIZATION OF MOU

Specific projects, as mutually agreed upon by the parties, shall be identified by CSJMU for assistance from NITTTR,K in which the scope and the deliverables of the specific project shall be stated. Further, the cost of the same, mode of payment and the time frame shall be spelt out on a case-to-case basis.

8.0 FORCE MEASURE

Notwithstanding any item contained in this MOU, neither Party shall be held responsible for actions beyond their control (e.g. natural calamity, law & order situation and so on) and no compensation shall be claimed by either Party from other nor shall be paid.

9.0 ARBITRATION

In case of disputes arising out of or related to any of the clauses contained in the MOU, it would be attempted to resolve the same bilaterally.

F) The Academy is anxious that the quality of the experiments conducted and instructions imparted in the said Refresher Courses are maintained at the same high standards as managed so far;

G) In the above facts and circumstances, it is found desirable and expedient that the Academy and the University enter into a workable arrangement through a MoU for achieving both meaningful participation and appreciable results;

NOW THEREFORE, THIS MoU SHALL WITNESS AS FOLLOWS:

I. Obligations, duties and responsibilities of the University:

1. The University shall follow the guidelines for Refresher Courses as formulated and as provided by the Academy from time to time.
2. The University shall present the budget to the Academy for each Course in accordance with the norms proposed by the Academy from time to time and the Academy after careful scrutiny will approve the same. The Academy may suggest modifications as it deems fit and necessary and the University shall abide by them.
3. The University shall make available standard laboratory items like oscilloscope, resistance boxes, multimeters etc. for use during these courses.
4. The text of the announcement for each Course shall be prepared by the University and sent to the Academy for approval at least four months in advance for publication in the relevant journals of the Academy as well as in other media.
5. The University will make available the required and adequate space, furniture and fixture, power, water and gas and any other things which may be a basic requirement for the making up of a full-fledged laboratory to conduct a Course for up to 30 (thirty) participants at a time for a period not less than 16 days at a stretch.
6. The University shall make available reasonable hostel/guest house accommodation for outstation participants/resource person during the whole period of such Courses. Such hostel accommodation and guest house as the case may be shall be made available for occupation immediately on arrival of the participants and resource persons respectively, at the venue or in nearby institutions.
7. The University will ensure that the participants and the resource persons are well taken care of as regards boarding during their stay in the hostel or guest house as the case may be through the duration of the Course
8. The certificates to be issued to the participants on successful completion of the Course should be according to the format prescribed by the Academy.
9. The University within a month shall submit to the Academy a report on the organized Course along with statement of expenditure and utilization certificate for the grant released by the Academy.

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (herein after referred to as MoU) is entered into on this date 26/09/2019 between University Institute of Engineering and Technology (UIET), CSJM University, Kanpur, and W3villa Technologies Private Limited (W3villa) having its registered office at WU 67C PITAMPURA DELHI North West DL 110034 IN and Business Office at 14/75 (Third Floor), Civil Lines - VIP Road, Kanpur, UP, India - 208001

The scope of the MoU, the roles and responsibilities of the parties of the MoU are given below:

Alliance Objective

This document outlines a strategic understanding between W3villa and UIET, CSJMU to work together to offer programs on mutual consent. Whichever Program is mutually decided upon initiative would allow UIET, CSJMU, one of the foremost institutions in India in the field of Education, and imparts training, among others in Computer Applications and Information technology faculties, to design world-class curriculum capable of delivering high caliber IT skills required in the fast changing IT marketplace.

NOW THIS MoU WITNESSETH AS FOLLOWS:

DEFINITIONS AS USED IN THIS MoU:

"MoU" means this instrument executed by W3villa and UIET, CSJMU and subsequent amendments issued to the MoU by mutual consent as provided herein.

"Program" means the Program that is the subject of this MoU.

"Software" or "Product" means the computer software packages identified for introduction in the Program.

"Curriculum" means the W3villa course that is integrated with the UIET, CSJMU's Main Course, elective or Projects.

1. BENEFITS TO THE UIET, CSJMU

Opportunity to emerge as one of the competent entities in the academic circles in research and development in the area of Information Technology;

Opportunity to be recognized by the industry and academic circles as one of the preferred locations for

acquiring training and skills development in latest technology and software;

Opportunity to utilise the Program to train students on W3villa Software products and technologies and services.

Opportunity for the faculty and students of UIET, CSJMU to design world class curriculum capable of delivering the caliber of IT skills required at present and also for the future.

Opportunity for students to avail Certification, which is valid across the globe.

Benefits to W3villa

Creation of a resource pool of W3villa Software professionals to boost the existing skill level in the country.

Availability of skilled students from the Program for projects which would benefit W3villa Customers as well as the Business Partners of W3villa.

1. RELATIONSHIP BETWEEN THE PARTIES

Neither UIET, CSJMU nor W3villa is or will be an agent or legal representative or partner of the other. Neither of them is or shall be responsible for the debts incurred by the other or be bound by any contracts or representations made by the other or any obligations undertaken by the other. Neither of them is or shall be an employee or franchisee of the other, nor does this MoU creates a joint venture or any similar relationship between them.

Neither party will make any representations pertaining to the other or its business or affairs, without the express prior written consent and approval of the other.


1. AREA OF COLLABORATION

W3villa Technologies

Software of whatever program mutually decided upon with UIET, CSJMU Curriculum design as agreed with W3villa.

UIET, CSJMU/University

- Setting up, operating & maintaining the infrastructure required for training
- Promotion of the Program among the students:
- The costs for the same to be borne by the student.
- Making available faculty, as per mutual convenience, for conducting training on site or customer premises on Payment Basis.
- Supporting in conducting fests/competitions for students in the UIET, CSJMU.
- Maintenance of trained faculty members for training on IT Curriculum.



2. MONITORING OF IMPLEMENTATION

A Co-ordination Committee consisting of two faculty members of UIET, CSJMU and two officers nominated by W3villa Technologies will do the planning and monitoring of the implementation of the various aspects of this MoU. There will be an annual review. This review would primarily focus on the curriculum progress, faculty availability and certification.

3. INTELLECTUAL PROPERTY

Title to the intellectual property rights of the software furnished by W3villa Technologies will at all times remain proprietary to W3villa Technologies, which however, The software's being provided to UIET, CSJMU through this MoU shall be governed by the applicable licenses agreements of the respective software UIET, CSJMU agrees to comply with such terms and conditions.

4. LIMITATION OF LIABILITY

Under no circumstances is W3villa liable for UIET, CSJMU's loss of, or damage to records or data, as also claims for special, incidental, or indirect damages or for any economic consequential damages (including loss of profit or savings) even if W3villa is informed of its possibility.

5. GENERAL

1. This MoU may be terminated by either party through a notice of one month. Either party may terminate this MoU if either of the parties is frustrated by reasons beyond it's control from going ahead with the implementation of the provision of this MoU. The provisions contained in Clauses 5 ("Intellectual Property Rights"), 6 ("Limitation of Liability") and 7 will survive any such termination.

2. Neither parties will make any presentations pertaining to the other or its business or affairs, without the express written consent and approval of others.

3. It is understood that during the course of this MoU it may be necessary for either party to disclose confidential/proprietary information to the other. The disclosure of any such information or data between the parties shall be made pursuant to an executed Confidentiality Agreement.

4. All costs incurred by a party pursuant to this MoU shall be borne by the party who incurred the costs.

5. There shall be no liability on the part of any party to the other arising from the termination of this MoU.

6. This MoU is not binding on either of the parties hereto, except as specifically set out hereto. This MoU is intended to express the broad understanding of the parties and as a broad framework for working together on a specific opportunity, as detailed herein.

7. The terms of the applicable software license agreements and terms relating to confidentiality under this MoU shall survive the term of the MoU.

8. Neither party may use the other's corporate name or any trade mark or name or any other items or



assets protected by intellectual property rights, including but not restricted to, use in any promotional material, press releases, advertisements, communications, stationery, web sites, or the like.

9. The W3villa software programs offered under the said MoU are for the specific purpose set forth in the MoU, namely for training the bonafide students of the UIET, CSJMU on W3villa software, and not for any other commercial purposes.

10. Neither party will disclose the existence, or the terms and conditions of this MoU or any information connected with it or any information received from the other or otherwise during the implementation of this MoU or its subsequent amendments, if any, except as may be required by law or on a strictly "need-to-know" basis for the purpose of implementing this MoU, or its subsequent amendments, if any, unless express prior written consent of the other party shall have been obtained in advance.

11. Save for their respective rights and obligations relating to Intellectual Property Rights (including the ownership of the Intellectual Property) as mentioned in Clause herein above, neither party is liable to the other for any damages or claims.

12. Unless previously consented to by both parties, there shall be no assignment of any interest under this MoU by any party hereto.

13. The laws of the Republic of India shall govern this MoU.

14. This MoU supersedes all proposals or other prior representations or communications, either oral or written.

15. All communication between the parties shall be in writing and in English Language.

Summary

MEMORANDUM OF UNDERSTANDING (MoU) FOR ACADEMIC AND SCIENTIFIC COOPERATION

CSJMU University, Kanpur

(UPTTI) Kanpur

This Memorandum of Understanding (MoU) is effective as of 21/11/2019 (Effective Date) to establish an affiliation by and between Chatrapati Sahu Ji Maharaj University, Kanpur, and UPTTI, Kanpur.

The aforesaid institutions are herein after referred to individually as institute and collectively as institutes. Preamble whereas Chatrapati Sahu Ji Maharaj University, Kanpur, and UPTTI Kanpur have many areas of common interest in Engineering and Sciences, considerable advantage may be gained from their pursuit on a collaborative basis in the fields of innovation, research and entrepreneurial activities. Now, therefore, Chatrapati Sahu Ji Maharaj University, Kanpur and UPTTI Kanpur have decided to enter into this Memorandum of Understanding (herein after referred to as MoU), which defines the framework for the cooperation of the two institutions set out in the following sections.

ARTICLE 1: OBJECTIVE - Both Institutes agree to develop the following collaborative activities in the areas of mutual interest, on a basis of equality and reciprocity.

The two institutions shall seek to promote:

- (a) Collaboration in innovation, research and entrepreneur activities in the field of mutual interest.
- (b) The exchange of start-up ideas.
- (c) Conducting events jointly such as TEDx, E-Summit, E-Factor and SIP.
- (d) Organising outreach activities to promote entrepreneurship.
- (e) Upgradation & development of Faculty/Students research products.
- (f) Entrepreneurial Promotion /Awareness Programs.
- (g) Conduct joint research on medical textiles, controlled drug delivery systems and other technical Textiles.
- (h) Ph.D. supervisor and co-supervisor will remain from UPTTI Kanpur and UIET, IBSBT CSJM University, Kanpur on common area of research interest.

Other Areas:

- (i) To exchange information on research programs.
- (ii) Jointly organize short-term continuing education programs on topics of mutual interest and to invite each other's faculty to participate therein.
- (iii) To organize jointly seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein.



- (iv) To propose and engage jointly in research or training programs sponsored by funding agencies, and to invite each other's faculty to participate therein.
- (v) To exchange, on a reciprocal basis, students at Undergraduate, Graduate and Doctoral levels for limited periods of time for purpose of education and /or research.
- (vi) The provision of cultural and intellectual enrichment opportunities for staff and students of both institutes
- (vii) To use laboratory facilities in specific cases for a limited period
- (viii) To permit students, staff and faculty members to use library facility.

ARTICLE 2: COORDINATION - Each institution shall appoint one member of its teaching/research faculty to coordinate the programme on its behalf. Further, a coordination committee consisting of a programme coordinator from the side of Chatrapati Sahu Ji Maharaj University, Kanpur and UPTTI Kanpur will periodically review and identify ways to strengthen cooperation between the two institutions.

ARTICLE 3: CONFIDENTIAL INFORMATION - Chatrapati Sahu Ji Maharaj University, Kanpur and UPTTI Kanpur does not absolve any confidential information during the research activity.

ARTICLE 4: INTELLECTUAL PROPERTY RIGHTS - Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MOU shall be vested in both institutes to this Memorandum. Both institutes shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both institutes shall make joint applications for the registration of the same.

-
- a) The MOU will use to share the facility of Artificial Intelligent and Deep Learning etc of CSJM University, Kanpur and Uttar Pradesh Textile Technology Institute, 11/208 Souterganj Kanpur.
 - b) Before any registration or commercialisation of any intellectual property takes place, the institutes agree to reach a separate agreement covering issues such as exploitation rights and revenue-sharing.
 - c) Any publication regarding such intellectual property shall only be possible with the prior written consent of both institutes, such consent not to be unreasonably withheld. Chatrapati Sahu Ji Maharaj University, Kanpur shall be free to use perpetually the results arising out of the collaborating activities for its own internal teaching, research, educational, and publication purposes without the payment of royalties or other fees to the other party.



ARTICLE 5: VALIDITY - The Memorandum shall remain in force for a period of FIVE years commencing from effective date. Institutions may extend the term by written agreement signed by both after review.




ARTICLE 6: TERMINATION - Either institution may terminate the MoU by giving written notice of six months in advance to the other institution. 


ARTICLE 7: AMENDMENTS/MODIFICATIONS - This MoU may be amended or modified by a written agreement signed by the representatives of both institutes.

ARTICLE 10: DISPUTE RESOLUTION - In case, there be a dispute relating to any aspect of academic cooperation, Chatrapati Sahu Ji Maharaj University, Kanpur and Director UPTTI Kanpur will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility. Chatrapati Sahu Ji Maharaj University, Kanpur and UPTTI Kanpur welcome the establishment of this Memorandum for cooperation and jointly agree to the provisions as set out above.
