



**Memorandum of Understanding
Between
Chhatrapati Shahu Ji Maharaj University, (School of Languages) Kanpur
&
Manprasth ITI (Unit of Manviya Prabandhan Sansthan)**

Representatives of CSJM University (School of Languages) & Manprasth ITI (Kanpur) have discussed the desirability and feasibility of an interactive relationship designed to strengthen the bonds between the two organisations. This Memorandum of Understanding is intended to enhance the English Speaking Skills of young technicians from the ITI, and also to provide hands-on knowledge of machinery and mechanics to the students of Technology at the University.

Objectives:

- To enhance English Speaking Skills of the young technicians.
- To develop Soft Skills in the young technicians.
- To provide University Students with hands-on knowledge of technical skills.
- To provide a joint "Value Enhancement Program" to the students of both institutions.

Operation:

Prior to actual visits of collaboration, the organisation will negotiate and sign a program agreement setting forth the specific obligations and responsibilities to carry out any of the following:

- Providing Language Lab to the students of Manprasth.
- To provide facilitators / teachers towards learning English Skills.
- This MOU shall be effective for a period of five (05) years from the last date of approval by the appropriate authorities of both organisations.
- This MOU may be extended for an additional five (05) years with written consent of both organisations.

Termination:

Either organisation may terminate this MOU at any time without any explanation of the cause by giving three months written notice to the other.

Language:

This MOU is prepared in English and both the organisations will agree to the same.

Arbitration:

Any controversy or claim arising out of or the breach thereof, shall be settled by arbitration administered by Chhatrapati Shahu Ji Maharaj University, Kanpur. The place of arbitration shall be Kanpur (UP). State law shall apply. Judgement on the award rendered by the arbitrator(s) may be entered in any court having jurisdiction Kanpur thereof.

Warranty Authority:


