


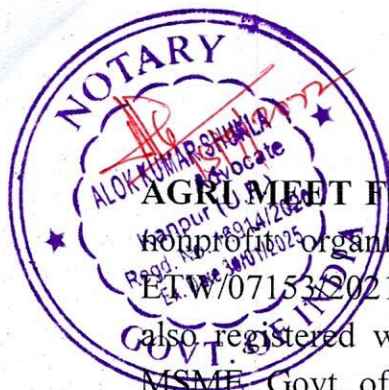


MEMORANDUM OF UNDERSTANDING (MOU)



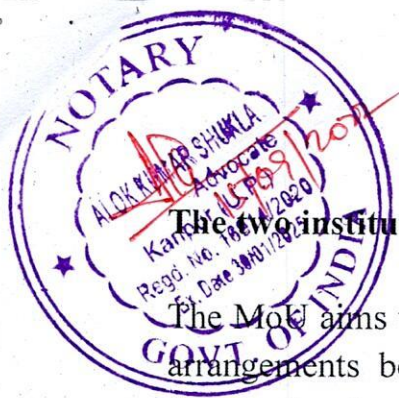

IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:-

1. Responsibilities of AMF

- ❖ The Parties hereby agree to work in coordination with each other by sharing of clients and knowledge in their respective fields of excellence, forming network amongst students, researchers, colleges, universities and industries, conducting informative events and such other contributions from each party for the benefit of the other.
- ❖ Establishment of Center of Excellence on Agriculture Drones and Agri Robots for training/research in the premises of CSJMU.
- ❖ The Parties shall devote its attention and energy to rendering the services under this Agreement to achieve best results for the purpose of this agreement.
- ❖ Jointly organize conferences, seminars, workshops, webinars, value-added programmes, Short Term Courses, Refresher Courses, Faculty Development Programme (minimum one-week duration), Student Exchange/Faculty-Research Scholar Exchange Programme, Technical assistance, Industry visits/Field projects/Internship/Short Term Visits related to academic/research work, Training and placement assistance, RAWI, ELP and Industrial attachment.

Responsibilities of CSJMU


- ❖ To provide infrastructure and manpower for event organization.

FINANCIAL ARRANGEMENT

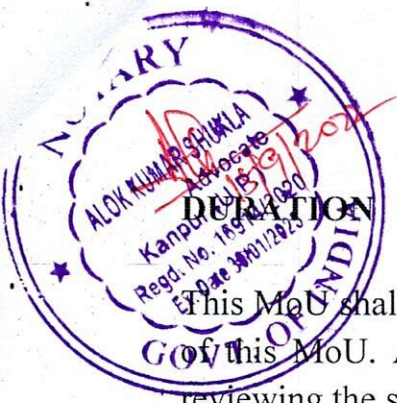

INTELLECTUAL PROPERTY RIGHTS

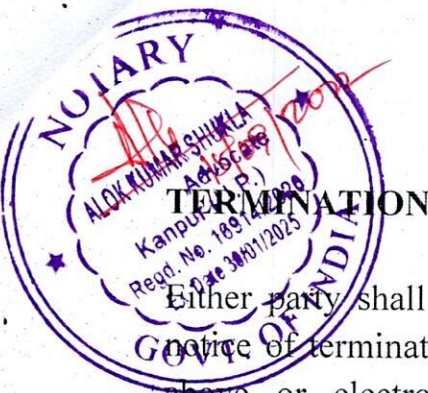
- ❖ As between the Parties, each party owns all rights, title and interest on the logo, the domain and the contents that are created and are available on the either party's website or any other advertising medium that is made available to the public.
- ❖ Nothing in this Agreement grants a party a license or any interest whatsoever in the Intellectual Property belonging to the other party.
- ❖ In case a party is using any content, logo, scientific procedures or such other things entitled for protection under intellectual property law that belongs to the other party is entitled to get prior permission from the other party, failing which the party owning the intellectual property can claim damages from the other party

CONFIDENTIALITY.

The Parties shall keep confidential all confidential information provided to them by the Party excepting only such information as is already generally known to the public and that he shall not release, use or disclose of the same except with the prior written permission of the party owning the confidential information or if required by law or an order from the Court. However, the Party will be entitled to divulge any information to those who are directly concerned or as may be necessary in order to obtain certain information necessary for the performance of its obligations.

Either party shall have the right to terminate this Agreement by giving written notice of termination to the other by registered post on the address given herein above or electronically via E-Mail to the mail id to which all official communications have been made. The Agreement shall terminate on the 10th day after such notice of termination.

Revision, Modification and Amendment

Either party may request in writing a revision, modification or amendment of all or any part of this MoU. Any revision, modification or amendment agreed to by the parties shall be reflected in writing and shall form part of this MoU. Such revision, modification or amendment shall come in to force on such date as may be determined by parties.


DISPUTE RESOLUTIONS

Any dispute or controversy arising relating to the interpretation of this Agreement shall be settled by arbitration in accordance with the rules of conciliation and arbitration of India. The place of arbitration shall be Etawah UP./Kanpur U.P. India and it shall be conducted in English/Hindi.

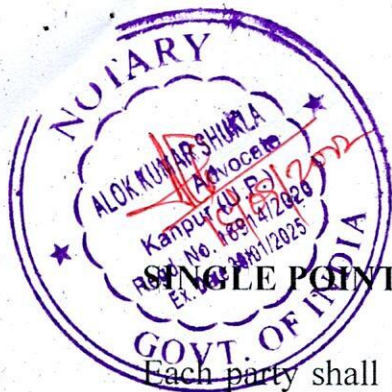
The MoU shall be governed and constructed in accordance with the Laws of India. The parties agree to submit to the exclusive jurisdiction of Kanpur Court in India in connection with any dispute between the parties under the MoU. In case any disputes arise in implementing the MoU, these shall be resolved by mutual consultation.

This Agreement and any services rendered hereunder are subject to all the applicable laws and regulations of India and the rights and obligations of the parties hereto under or in connection with this Agreement shall be determined in accordance with the laws of India.

INDEMNIFICATION



Neither party hereto shall be liable for any failure to perform its obligations here under to the extent that performance has been delayed, hindered or prevented by any circumstances beyond the reasonable control of that party, including without prejudice to the generality of the foregoing, any act of God, war, riot, civil, commotion, strike, lock-out or other form of industrial action or any form of government or supernatural authority intervention.

The affected party to be able to avail of this clause will be obliged to inform the other party of:

(a) The occurrence of any such event of force majeure; and

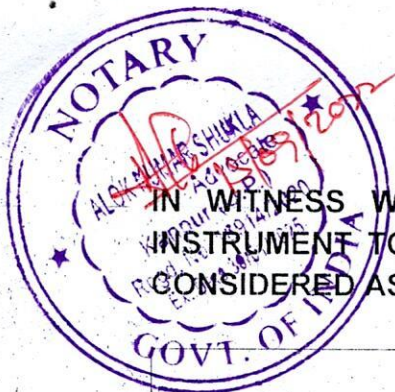
Resume its responsibilities on the cessation of such force majeure event.

- ❖ If any doubt arises as to the interpretation of the provisions of this agreement or as to matters not provided therein, the parties to this agreement shall consult with each other for each instance and resolve such doubts in good faith.
- ❖ In case of dispute or difference arising out of, or in connection with, this MoU, the same shall be settled through mutual discussions between Agri Meet Foundation UP India and CSJMU Kanpur.
