



ABOUT CSJMU

Chhatrapati Shahu Ji Maharaj University (CSJMU), formerly known as Kanpur University, was established in 1966 and is recognized as a leading research-oriented State University in North India, distinguished by its longstanding legacy of academic excellence. In November 2023, the University attained a significant milestone by being awarded the prestigious A++ grade by the National Assessment and Accreditation Council (NAAC). It has also been accorded Category-I University status under the UGC Regulations, reaffirming its commitment to quality higher education and research.

Spread over a 264-acre campus, CSJMU offers 39 undergraduate and 47 postgraduate programmes, including Ph.D.s, along with various diplomas and certificate courses. ABOUT THE EVENT

The Atal Bihari Vajpayee School of Legal Studies (ABVSLS) is organising the First Edition of the District Client Counselling Competition, as part of its continued commitment to practice-oriented legal education. The competition is scheduled to be conducted on 13th and 14th March, 2026, and is intended to provide law students with an opportunity to engage in simulated lawyer–client interactions reflective of real district court practice.

The competition is expected to witness participation from approximately 20 teams, representing various law institutions. Participants will be required to counsel clients on hypothetical legal problems drawn from commonly encountered areas such as family disputes, criminal matters, consumer issues, property, labour, and social welfare laws. Students will assume the role of legal counsel and conduct counselling sessions focusing on fact identification, issue spotting, legal advice, and client communication in a professional and ethical manner.

The event will be conducted in multiple competitive stages, beginning with Preliminary Rounds, followed by Quarter-Final Rounds, and culminating in the Advanced Rounds, which will include the Semi-Final and Final rounds. Each stage is designed to progressively assess participants on counselling skills, legal understanding, client rapport, ethical awareness, and overall professional conduct, under the evaluation of experienced legal professionals.

By hosting the first edition of this district-level competition, ABVSLS aims to strengthen grassroots legal training, encourage wider student participation, and create a platform that bridges academic learning with the practical realities of client counselling and legal practice.



THE VISION

The vision of the District Client Counselling Competition is to bridge the gap between classroom instruction and professional legal practice by cultivating socially responsive, ethically grounded, and practice-ready law graduates. Through client-focused advocacy and counselling, the event aims to promote access to justice, professional responsibility, and a deeper understanding of the lawyer's role in serving the community at the grassroots level.

 - Participants from Institutions other than ABVSLS: ₹1200*
 - Participants from ABVSLS: ₹1,000
- The confirmation of Registration will be notified to the teams by the MCS after the completion and verification of the Registration formalities.
- For ABVSLS students, registration will be provisional, subject to approval by the Moot Court Society (MCS)
- The teams will be provided with a Team Code, and at any stage of the Competition, a team must be identified only by the allotted team code.
- All team members must refrain from disclosing the identity of their Institution at any time and in any manner during their participation in the Competition. Non-compliance with this rule shall lead to severe penalty or disqualification as determined by the MCS.
