Recirculating chiller for rotary evaporator must have the following specifications:

- 1. Compact & robust recirculating chiller with a cooling capacity of 250 to 500 Watts at 15°C (500 Watts desirable)

- 3. Pump capacity: 2.5 L/min at 0.6 bar and tank capacity 3 L or more
- 4. Coolant: CFC free5. Refrigerant: R 134a
- 6. Controller: Auto Controller
- 7. Temperature regulation accuracy: $\pm 1^{-1}$ C
- 8. Prefer to have facility to connect with vacuum controller for direct operation by controller
- 9. Digital display for set and actual temperature
